PROGRAMS, REGISTRATION, & POLICIES

Our childcare services are offered for students who are currently enrolled at SWS, on days when school is in session for full days. This one-time registration form must be submitted prior to or on the first day your child attends. The following programs are licensed by the PA Department of Human Services (DHS).

Stepping Stone: Nursery program for ages 2-3 offered Monday-Friday from 8:15-11:00 a.m.

Billed annually and divided into the monthly tuition payments. Second Semester (January 4th -May 27th)

- 2 days: \$2,125 3 days: \$2,395 4 days: \$3,250 5 days: \$3,750

Afternoon Garden: Mixed-age Kindergarten classes offered Monday-Friday from 12:00 to 3:15 p.m.

Billed annually and divided into the monthly tuition payments:

- 2 days: \$1,925 3 days: \$2,400 4 days: \$3,200 5 days: \$3,850

Sunset: Afterschool childcare provided only to faculty children on Thursdays 3:30-5:30 p.m.

Medical Release Form

By signing this form, the parent or guardian allows SWS to copy school health records and file them in the required DHS file. This form must be signed and returned to the office before children are able to attend programs.

Pick Up Time

All programs are required by DHS to have a roster of who is able to pick up the child.
